## **DATA SUBJECT RIGHTS UNDER GDPR**

- **Right of Access to Information** you have the right to request confirmation from us whether personal data relating to you is being processed and if so to access such personal data.

- **Right to lodge a request** If you would only like to receive information on a specific category of data, please contact us and indicate such category.
- **Right to Rectification** you have the right to request from us the rectification, without delay, of any inaccurate personal data pertaining to you.
- **Right to erasure** you have the right to request from us the erasure of all personal data pertaining to you without delay, where the data has been processed with your consent as the basis for processing and/or where the processing is no longer lawful.
- **Right to Restrict Processing** You have the right to request that we erase your personal data, under certain conditions. You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
- **Right to Object** you have the right to object at any time to the processing of personal data, under certain conditions.

You also have the right to object to profiling based on our legitimate interests or on the performance of a task in the public interest/exercise of official authority. You also have the right to object to automated decision making, including profiling, and therefore to not be subject to a decision which is based solely on automated processing, including profiling, which produces legal effects or significantly affects you.
